e. Block funding - \$23,118

- iv. Remaining funding could go to students based on publications from the year– what else could we do?
 - 1. Call for research projects make the call specific so the advisor isn't being funded
 - 2. Page charges would require that the publication has already been submitted (doesn't work as well for master's students)
 - 3. Could divide the remaining funds evenly among the students

- 4. Allocate a portion for publications and the remainder divided publication requests due April 1st
- II. Environmental Science and Ecosystem Ecology
 - a. Should be approved by the end of December will be active Fall 2021; Forest Science will disappear
- III. Graduate Student Symposium
 - a. 4 sessions throughout the day with 5 talks per session
 - b. Posters will be handled via breakout rooms during the lunch break
 - i. Digital versions will be shared a week in advance
 - c. We need judges for the posters and talks
 - d. Abstracts will be due on January 8th and the symposium will be January 22nd
 - e. Can the Sparks/Witt fund supplement awards this year?
- IV. IPS 610/625 Changes
 - a. IPS 610 Given the option, most students chose to attend remotely Mark is considering a change to online for the future
 - b. IPS 625 next Fall 2021 will follow in Dave Van Sanford's footsteps but will be offered immediately again in Spring 2022 to take advantage of the Farm Machinery Show in Louisville (have faculty attend and discuss in front of machinery how it is used in their programs)
- V. Courses
 - a. Put out recommendation to departments on course offerings
 - i. Balance between Fall and Spring
 - b. Focus on 600- and 700-level classes

 - a. GSA flow chart/checklist of the program
